

Settle & Giggleswick Golf Club Safety Notice

It is the policy of Settle & Giggleswick Golf Club to safeguard, so far as is reasonably practical and possible, the health, safety and welfare of all club members, employees and visitors when using the club's facilities.

However every person using the course, clubhouse and carpark has an overriding responsibility for their own safety and the safety of others affected by their actions.

Settle & Giggleswick Golf Club does not accept liability for any loss resulting from any cause suffered by any person using the course, clubhouse or car park



Please be aware and take care as the course is steep in places with sheer drops, uneven ground and water hazards. The whole course becomes slippery in wet and icy conditions, please take extra care in these conditions.

Due consideration must be given to road safety, especially when crossing the road, playing the 9 and 18 holes and using the practice area.



Players should not tee off on the 1st/10th holes when players are on the 2nd tee bed.

Players should not play until the players in front are out of range

Players should ensure that no one is standing close by or in a position to be hit by the club, the ball or any stones, pebbles, twigs or the like when they make a stroke or practice swing.

If a player plays a ball in a direction where there is a danger of hitting someone, they should immediately shout a warning. The traditional word of warning in such situations is "FORE!". **On hearing "FORE!",** crouch, cover your head with your arms and count to 10.

GOLFERS ARE REMINDED OF THE NEED TO SHOUT "FORE" IF YOU CANNOT SEE THE FULL RANGE OF ANY WAYWARD SHOT ONTO ADJACENT FAIRWAYS



GREENS STAFF: have priority at all times. Players must always alert greens staff nearby or ahead when they are about to make a stroke which may endanger them.



PUBLIC FOOTPATH and ROAD to HUNTWORTH FARM: Be aware of and give priority to users of the public footpath and farm track, which crosses holes 1, 6, 7 and 8. Golfers must not tee-off until the footpath and farm track ahead of them are clear.

ANYONE USING THE GOLF CLUB FACILITIES HAS A DUTY OF CARE FOR THEMSELVES AND THE SAFETY OF OTHERS AFFECTED BY THEIR ACTIONS



FOG & LIGHTNING: In the event of an electrical storm, suspend play immediately and take appropriate action. (Rule 6-8a applies). Do not tee off or continue play in fog/poor visibility when you cannot see the clear distance of your intended shot. All players use the course at their own risk.



FIRST AID: Defibrillator, First Aid box and Emergency Phone are available in the Lobby in the Clubhouse. Report all accidents to the Secretary.

You are advised to carry a mobile phone to summon assistance in an emergency. Settle & Giggleswick Golf Club does not accept responsibility for assisting injured persons off the course.

RING 999 FOR AN AMBULANCE, CLEARLY STATING YOUR LOCATION - POSTCODE BD24 0DH. AMBULANCE ACCESS IS VIA A GATEWAY NEXT TO THE 2ND GREEN AND HUNTWORTH FARM TRACK (Hole 7/8 &9)

All accidents must be reported to the Secretary and recorded in the accident book provided.
